1. Minutes of the WVA meeting on 10th January 2019

2. Matters Arising

- a. Committee Vacancies proposed candidates

It was agreed that TW would get in touch with proposed candidates Gavin Musgrave and Catherine Stevens. TW stressed that being a Trustee meant much more than merely attending meetings, and only wished for people to

accept such positions if they were able to commit to investing the necessary time to making a difference in the village. Andrew Copeland suggested Nick Lund as a possible candidate, and was asked by the committee to discuss the matter with him.

HW stated that she had met with County Council parking officers last week (w/b 11th February). They hoped to finalise the parking plans in March, at which point they will be published on the County Council website. HW said that all those who had responded to the consultation would be contacted.

c. Website

TW congratulated AC and Jo Astor on the excellent new website. BB commented that the Facebook page was receiving many hits. AC commented that there was much more that we could now be doing to market what it is that the WVA actually does. Given that next year's subscriptions would be falling due in a few months' time, this could be a good opportunity. TW asked AC to produce a short one pager of how the WVA could work more effectively through the use of new technology.

AC agreed and said that he would include in this an assessment of the feasibility of paying subscriptions electronically. He believed that PayPal was the most viable option.
